2. From the State Project Director, Sarva Shiksha Abhiyan, Letter No. 175/A15/PTI/SSA/2014, dated 5.11.2014.

ORDER:-

In the Government Order first read above, the Government issued orders regarding recruitment process for the appointment of 16549 Part Time Instructors in Government schools for standard VI to VIII.

2. The Project Approval Board to consider the Annual Work Plan and Budget (AWP&B) 2014-15 for Sarva Shiksha Abhiyan, National Programme for Education of Girls at Elementary Level (NPEGEL) and Kasturba Gandhi Balika Vidyalaya (KGBV) for the State of Tamil Nadu, Department of School Education and Literacy, Ministry of Human Resource Development, Government of India has enhanced the salary of the 15169 Part Time Instructors (in position) from Rs.5000/- to Rs.7000/- and this was accepted in the 48th Executive Committee meeting of Sarva Shiksha Abhiyan.

3. Subsequently, the State Project Director, Sarva Shiksha Abhiyan has requested to issue necessary amendment to the Government Order first read above.

4. The Government considering the proposal of the State Project Director, Sarva Shiksha Abhiyan issues the following amendment to the G.O (Ms) No.177, School Education, dated 11.11.2011 :-

AMENDMENT

- (1) In the sub para 3 of para 3.1, the words "Part Time Teachers" should be read as "Part Time Instructors".
- (2) For the sub para 4 of para 3.1, the following is substituted:-
"The salary of Part Time Instructors is increased from Rs.5000/- to Rs.7000/- from April 2014 onwards".
- (3) After the last para of para 3.1, the following para is inserted :-
"Based on eligibility criteria of schools, redeployment of category wise Part Time Instructors within the District will be done by the Chief Educational Officers after approval of the State Project Officer, Sarva Shiksha Abhiyan".

(4) In the last sub para of para 3.2 for the words "Village Education Committee (VEC) proportionally" the words "Head Master of the school concerned" is substituted.

(5) For the first sub para of para 3.3, the following is substituted :-

"Amount for salary may be released by Additional Chief Educational Officer of Sarva Shiksha Abhiyan of the District concerned by Electronic Clearing Service (ECS) to Village Education Committee / School Management Committee account on / before the last two working days of every month. Head Masters of the schools concerned are to draw the salary and to pay the salary on the first working day of next month after getting proper acquittance and after deducting the proportionate salary for the days of absence. The deducted amount should be returned to Additional Chief Educational Officer of SSA before 5th of the succeeding month". Acquittance for disbursement should be obtained.

(6) In the sub para 2 of para 3.3, for the words "Village Education Committee" the words "Head Master of the school concerned" is substituted.

(7) In the last sub para of para 3.3 the following is substituted :-

"The services of the selected Part-Time Instructors may be utilized for maximum 2 schools (nearby) where there is shortage of selected candidates available. In this case, the Part-time Instructors may be paid for both the schools and in both the schools they should be asked to serve for 3 half days."
